

# WVAEA, Inc. Board of Directors' Meeting Thursday, June 15, 2023

Kari Geary (Vice President) provided an update on conference planning activities for 2023. The conference is scheduled for the week of September 12-15 at the Charleston Marriott; schedule and registration should be available by mid-summer; currently looking at various locations for the 2024 conference.

Kim McConnaughy (Exec. Dir.) provided an overview of the role of State Advocate Adult Education Fellowship with COABE. WV's advocate this year is Lucy Lester. Primary responsibilities of the role are to serve as a liaison between the AE Association and COABE. Will work closely with the legislative liaison to enhance communication with legislators; currently working with the Governor's Office to sign a proclamation for Adult Education & Family Literacy Week (Sept 18-24) and build stronger relationship through COABE initiatives.

# **OLD BUSINESS:**

Tina reminded the Board that the name of the Special Events Grant needs updated on the webpage to reflect the approval of changing the name to the Hollingsworth Special Events Grant per the November 2022 board meeting.
